

Long Island Business News Editor Joe Dowd and Marcum Melville Office Managing Partner Carolyn Mazzenga are set to moderate a series of panel discussions tonight on the impact of the new federal income tax laws.

Marcum and LIBN are presenting the dinner and panel discussions designed to help Long Islanders understand and plan following the passage of the Tax Cuts and Jobs Act of 2017.

The free event and dinner, where registration is required, is slated to take place today, Tuesday, Jan. 30 from 5 p.m. to 8 p.m. at the Melville Marriott, 1350 Walt Whitman Rd., in Melville.

Dinner and networking are at 5 p.m. followed by panel discussions from 6 p.m. to 8 p.m. dealing with business taxes, personal taxes, financial planning and estates and trusts.

“The Tax Cuts and Jobs Act fundamentally changes the tax landscape and affects nearly every business and individual in the country,” Mazzenga said in a written statement. “The actions you take – or don’t take – will have far-reaching tax implications.”

While a lot has been written about the changes in the tax rules, Mazzenga said they impact tax planning strategies as well.

“Many of the tax planning techniques that were standard protocol are now obsolete or in need of revision,” she added. “The event is geared to let Long Islanders know what they should be doing now to prepare.”

Michael D’Addio, Marcum tax principal, is leading a panel covering business taxes and Robert Spielman, Marcum tax partner, is leading a panel on personal taxes.

The estates and trusts panel is being led by Janis Cowhey, Marcum tax partner, and the panel on financial planning is being led by Steven Brett, president of Marcum Financial Services.
