## Marcum to expand in Philadelphia

Top 20 Firm Marcum will merge in Horsham, Pennsylvania-based Silverman Kendall LLC, effective Jan. 1, 2019.

Financial terms of the deal were not disclosed. The Silverman Kendall team will join Marcum's Center City Philadelphia office, and Samuel Silverman and Jordan Kendall will join Marcum as partners.

"We clicked with Marcum from the outset," Silverman said in a statement.
